ADOPT A ROAD PROGRAM

To enhance the environment and appearance of the City's roads:

The City hereby grants permission to Permittee to perform the work hereinafter described on the Roadway:

- 1) The work will be performed in compliance with the Adopt A Roadway Program Guidelines attached hereto. The Permittee is authorized only to pick up litter and trash on the designated Roadway pursuant to the rules contained herein. Permittee is not authorize to conduct any additional activities, including the installation of improvements.
- 2) Permittee shall perform all work in compliance with all applicable laws, rules and regulations related to highway utilization, safety and all other conditions as required by the City for the particular Roadway.
- 3) Permittee and all other individuals who volunteer to provide services pursuant to the Permit shall execute a Release and Indemnity Agreement releasing the City from any and all liability related to the activities conducted pursuant to this Permit.
- 4) This Permit is a license authorizing the Permittee and other volunteers the right to enter on the City's right of way solely for the purpose outlined herein. This Permit is revokable by the City at any time, with or without cause, solely in the discretion of the City.
- 5) Permittee acknowledges that the work authorized pursuant to the Permit is inherently risky as it involves performing work in close proximity to moving vehicles. Furthermore, the City makes no representations as to the condition and safety of the area the work will be performed. The Permittee shall inspect the work area and make sure all volunteers are aware of any conditions that could cause harm. If the Permittee determines that dangerous conditions exist, the Permittee shall have the right to cancel any work being performed and shall immediately notify the City
- 6) Permittee and all other individuals perform work under this Permit shall at all times be consider volunteers and not employees of the City. Permittee and all volunteers shall receive no compensation for services and shall receive no benefits such as worker's compensation benefits, health insurance, retirement or sick/vacation time.
