

**ORDINANCE NO. 2885**

**AN ORDINANCE AMENDING ORDINANCE NO. 2855 THE APPROPRIATIONS BUDGET FOR THE CITY OF HOLLY HILL, FLORIDA, FOR THE FISCAL YEAR OCTOBER 1, 2009 THROUGH SEPTEMBER 30, 2010; PROVIDING FOR CONFLICTING ORDINANCES; AND PROVIDING WHEN THIS ORDINANCE SHALL TAKE EFFECT.**

**WHEREAS**, the governing body of each municipality is required to make appropriations for each fiscal year, pursuant to Florida Statute 166.241; and

**WHEREAS**, it is necessary to adopt a budget, whereby the collection of revenues to offset appropriation expenditures is assured; and

**WHEREAS**, the City Commission of the City of Holly Hill, Florida pursuant to Florida Statute 200.065, the TRIM BILL, held a public hearing and adopted a budget, publicly announcing the millage rate; and

**WHEREAS**, it is necessary to make a year-end adjustment to the appropriations budget to reflect actual and planned expenditures for the balance of the year.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLY HILL, FLORIDA:**

**SECTION 1.** That Ordinance No. 2855, the appropriations budget for the fiscal year October 1, 2009, through September 30, 2010, is hereby amended in accordance with the attached Amended Appropriations Budget which is hereby approved and adopted as an amended final budget.

**SECTION 2.** That all ordinances in conflict herewith are hereby repealed.

**SECTION 3.** That this Ordinance shall become effective immediately upon its adoption.

The within and foregoing Ordinance was introduced and read on first reading before the City Commission of the City of Holly Hill, Florida, at its regular meeting held in Commission Chambers at City Hall on the 9<sup>th</sup> day of November, 2010.
