

ORDINANCE NO. 2886

AN ORDINANCE OF THE CITY OF HOLLY HILL, FLORIDA AMENDING THE ADOPTED COMPREHENSIVE PLAN, AS PREVIOUSLY AMENDED, BY REVISING MAP 1, THE FUTURE LAND USE MAP, TO CHANGE THE FUTURE LAND USE DESIGNATION OF APPROXIMATELY 1.6 ACRES CONSISTING OF TAX PARCEL NUMBERS 4244-01-20-0060 AND 0061 FROM LOW DENSITY RESIDENTIAL TO GENERAL COMMERCIAL; PROVIDING FOR SEVERABILITY; REPEALING ALL LAWS OR PARTS OF LAWS IN CONFLICT HEREWITH; AND PROVIDING WHEN THIS ORDINANCE SHALL TAKE EFFECT.

WHEREAS, s. 163.3161-3243, Florida Statutes, gives to the City of Holly Hill the power and the responsibility to prepare and adopt a comprehensive plan and to amend said comprehensive plan applicable to the area within its jurisdiction; and

WHEREAS, on January 22, 1991, the City Commission of the City of Holly Hill did adopt a Comprehensive Plan pursuant to Chapter 163, Part II, Florida Statutes; and

WHEREAS, Halifax Media LLC, the owner of the subject property has requested amendment of the City of Holly Hill Future Land Use Map, and

WHEREAS, the City Commission of the City of Holly Hill, has determined that the future land use map amendment of the Comprehensive Plan as requested and as herein prescribed is consistent with the goals and objectives expressed in the Plan; and

WHEREAS, the City Commission believes this amendment is in the best interest of the citizens of the City.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION
OF THE CITY OF HOLLY HILL, FLORIDA:**

SECTION 1. That Map 1, the Holly Hill Future Land Use Map, is revised by including the properties described below and shown in attached Exhibit A, and assigning a “General Commercial” Future Land Use designation to said properties as shown in Exhibit A.

2. Volusia County Tax Parcel #4244-01-20-0060, 4244-01-20-0061

SECTION 2: That if any section, sentence, clause or phrase of this ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portion of this ordinance.

SECTION 3. That all laws or parts of laws in conflict herewith are hereby repealed.

SECTION 4. That this ordinance shall be published, by title only, at least once in a newspaper of general publication in the City of Holly Hill prior to its final passage and in accordance with Section 163.3184(15)(c), Fla. Stat.

SECTION 5. That this Ordinance shall become effective immediately upon issuance by the state land planning agency of a final order determining the adopted plan amendment to be in compliance in accordance with s. 163.3184(9), or upon issuance by the

Administrative Commission of a final order determining the adopted plan amendment to be in compliance in accordance with s. 163.3184(10).

The within and foregoing Ordinance was introduced and read on first reading before the City Commission of the City of Holly Hill, Florida, at its regular meeting held in Commission Chambers at City Hall on the 11th day of January, 2011.

It was moved by Commissioner Glass and seconded by Commissioner Moore that said Ordinance be approved on first reading. A roll call vote of the Commission held on said motion for approval of the Ordinance resulted as follows:






