(APPLICABLE TO COUNTY, MUNICIPAL AND SPECIAL DISTRICT CANDIDATES & PACS)

Filing Campaign Treasurer's Reports

Section 106.07 – Each candidate or political committee who is required to file reports with a county or municipal filing officer must file reports on the 60th day immediately preceding the primary election, and biweekly on each Friday thereafter through and including the 4th day immediately preceding the general election, with additional reports due on the 25th and 11th days before the primary election and the general election.

Section 106.07 – Reports shall be filed on the 10th day following the end of each calendar month from the time the campaign treasurer is appointed until qualifying begins.

90-Day Termination Report

Section 106.141(1) – Each candidate who withdraws his or her candidacy, becomes an unopposed candidate, or is eliminated as a candidate or elected to office shall, within 90 days, dispose of the funds on deposit in his or her campaign account and file a report reflecting the disposition of all remaining funds.

NOTE: The campaign treasurer's report schedule included in this document is current up to the 2016 qualifying period for county offices.

2016 Qualifying period:

US Sen., US Rep., Judicial, State Attorney and Public Defender

Noon, May 2 – Noon May 6, 2016

St. Senator, St. Rep, County Office and Spec. Districts

Noon, June 20 – Noon June 24, 2016

Municipal candidates should check with the city clerk to verify what the qualifying dates are for the municipality.

Deadline for Filing

Section 106.07(2) (a) – Reports shall be filed no later than 5:00 p.m. on the day designated. Any report postmarked by the U.S. Postal Service no later than midnight of the day designated shall be deemed to have been filed in a timely manner. A certificate of mailing obtained from and dated by the U.S. Postal Service at the time of mailing, or receipt from an established courier service that bears a date on or before the date on which the report is due, shall be proof of mailing in a timely manner.

Section 106.07(7) – In any reporting period when there has been no activity in the account (no funds expended or received) the filing of the required report may be waived by notifying the filing officer in writing on form DS-DE 87 that no report is being filed.

Qualifying with filing officer

All reports of a candidate shall be filed with the officer before whom the candidate is required by law to qualify. Municipal candidates file with their City Clerk.

Political committee reports shall be filed with the agency or officer before whom such committee registers.

Municipal candidate petitions must be handed in to the City Clerk's office unless other arrangements are made in cooperation with the filing officer.
